

PRIVACY POLICY

1. Who we are

1.1. NOTIONSSTOCK - FZCO company incorporated under the law of the United Arab Emirates, with registered number DSO - FZCO-24070, with registered address: IFZA Business Park, DDP Premises number 25830-001, Makani Number A1-3641379065, Dubai Silicon Oasis, Dubai, United Arab Emirates ("Company" or "Notionsstock").

1.2. This privacy policy provides an overview of how the Company collects and uses information, that is obtained through the Company's website: <https://adprofex.com/> - the advertising platform service, which serve ads either on Company's website or on third-party websites and informs you about your rights under the UAE data protection law - Federal Decree-Law No. 45 of 2021 year (hereinafter - "Law") supplementing or implementing the Personal Data Protection.

Contains important information about, among others, the collection and use of personal data; the legal grounds for the processing of that data; disclosures of that personal data to third parties and the use of cookies on the Website.

1.3. The Company website (or Service) is owned and operated by Notionsstock (referred to in this Policy as "Company", "Notionsstock", "we", "our", or "us").

1.4. By using the Notionsstock Service, you agree to observe and be bound by this Privacy Policy and you consent to the processing, collection, use, and disclosure of your information and data in accordance with the terms of this Privacy Policy. Please do not use the Notionsstock website if you do not agree to this Privacy Policy.

1.5. The use we make of the Information, including Personal Information, collected through the website and Services may vary depending on whether you are (i) a customer ("Customer"), i.e., a advertiser, partner, with whom we have a contractual relationship; (ii) a visitor of our Customers' websites who interacts with our Services ("User"); or (iii) or a visitor of our own website ("Site Visitor"), which may include Customers as well as prospective customers.

This Privacy Policy should be read alongside, and in addition to, our Terms and conditions (accessible online at https://adprofex.com/doc/privacy_policy.pdf).

In case of any contradictions between this Privacy Policy and the Terms, this Privacy Policy will prevail.

1.6. For the purposes of this privacy policy:

1.6.1 when we refer to “personal data” we mean data which identifies or may identify you and which may include, for example, your name, address, identification number, telephone number, date of birth, occupation and family status;

1.6.2. when we refer to “processing” we mean the handling of your personal data by us, including collecting, protecting and storing your personal data;

1.6.3. when we refer to our “Website” or our “Service” we mean [notionsstock.com](https://www.notionsstock.com)

2. Our Data Protection Principles:

2.2.1. We adhere to the principles relating to processing of personal data set out in the Law which require personal data to be:

2.2.2. Processed lawfully, fairly and in a transparent manner (Lawfulness, Fairness and Transparency).

2.2.3. Collected only for specified, explicit and legitimate purposes (Purpose Limitation).

2.2.4. Adequate, relevant and limited to what is necessary in relation to the purposes for which it is Processed (Data Minimisation).

2.2.5. Accurate and where necessary kept up to date (Accuracy).

2.2.6. Not kept in a form which permits identification of data subjects for longer than is necessary for the purposes for which the data is Processed (Storage Limitation).

2.2.7. Processed in a manner that ensures its security using appropriate technical and organizational measures to protect against unauthorized or unlawful processing and against accidental loss, destruction or damage (Security, Integrity and Confidentiality).

2.2.8. Not transferred to another country without appropriate safeguards being in place (Transfer Limitation).

2.2.9. Made available to data subjects and data subjects allowed to exercise certain rights in relation to their Personal Data (Data Subject's Rights and Requests).

2.2.10. We are responsible for and must be able to demonstrate compliance with the data protection principles listed above (Accountability).

3.2.1 We obtain your personal data mainly through any information you provide directly to us or through information provided by third parties. Below is a list of ways in which we collect your personal data.

Personal data collected directly from you, including:

- when you complete our Partner or Advertiser registration forms, which are available on our Website,

- when you enter and use our Website, and/or performing contractual obligations, and
- when you contact us for any enquiries, complaints or for any other reason.

3. Cookie Policy

3.1. We use cookies for a variety of reasons detailed below. Unfortunately in most cases there are no industry standard options for disabling cookies without completely disabling the functionality and features they add to this website. It is recommended that you leave on all cookies if you are not sure whether you need them or not in case they are used to provide a service that you use.

3.2. You can prevent the setting of cookies by adjusting the settings on your browser (see your browser Help for how to do this). Be aware that disabling cookies will affect the functionality of this and many other websites that you visit. Disabling cookies will usually result in also disabling certain functionality and features of this website. Therefore it is recommended that you do not disable cookies.

3.3. The Cookies we set

- Account related cookies
If you create an account with us then we will use cookies for the management of the signup process and general administration. These cookies will usually be deleted when you log out however in some cases they may remain afterwards to remember your site preferences when logged out.
- Login related cookies
We use cookies when you are logged in so that we can remember this fact. This prevents you from having to log in every single time you visit a new page. These cookies are typically removed or cleared when you log out to ensure that you can only access restricted features and areas when logged in.
- Orders processing related cookies
This site offers e-commerce or payment facilities and some cookies are essential to ensure that your order is remembered between pages so that we can process it properly.

3.4. Third Party Cookies

In some special cases we also use cookies provided by trusted third parties. The following section details which third party cookies you might encounter through this site.

- Third party analytics are used to track and measure usage of this site so that we can continue to produce engaging content. These cookies may track things such as how long you spend on the site or pages you visit which helps us to understand how we can improve the site for you.

4. Information we collect about you

4.1. We set out in more detail the information we collect when you use our Services, why we collect and process it and the legal bases below.

4.2. Our legitimate interests include (1) maintaining and administering the Services; (2) providing the Services to you; (3) improving the content of the Services; (4) processing of the information that you choose to provide to us via email or submitting on our website or Service; (5) ensuring your account is adequately protected; and (6) compliance with any contractual, legal or regulatory obligations under any applicable law.

4.3. As part of maintaining and administering the Services we may use the information to analyze user activity and ensure that rules and terms of use for the Services are not violated.

4.4. Information We May Provide to Third Parties:

4.4.1. We may disclose your personal data to the third parties listed below. When we do so, we require those third parties to have appropriate technical and organisational measures in place to protect your personal data. We will not share any of your personal data for any purpose other than the purposes described in this privacy policy, nor will we sell your personal data to anyone.

4.4.2. To our insurers and/or professional advisers insofar as reasonably necessary for the purposes of managing risks, obtaining professional advice, or the establishment, exercise or defence of legal claims, whether in court proceedings or in an administrative or out-of-court procedure.

4.4.3. Payment services providers we have chosen to support us with financial transactions relating to our Service. We will share transaction data with our payment services providers only to the extent necessary for the purposes of processing your payments, refunding such payments and dealing with complaints and queries relating to such payments and refunds.

4.4.4. Governmental and regulatory bodies, including law enforcement authorities, in connection with enquiries, proceedings or investigations by such parties or in order to enable Propeller to comply with its legal and regulatory requirements.

4.4.5. Partners, contractors and/or vendors in order to perform contracts we have with you.

4.5. Your data protection rights:

4.5.1. You have the following rights in terms of the personal data we hold about you:

5. International Transfers of Your Personal Data

5.1. We don't envisage that any of your personal data will be transferred to countries outside the United Arab Emirates (UAE) as our office, facilities, subcontractors and other third parties with which we work are all located within the UAE.

5.2. In the event that this changes in the future and one or more recipients of your personal data are located outside the UAE, where data protection laws may be of a lower standard than in the UAE, we will impose the same data protection safeguards that we deploy inside the UAE to ensure that your personal data are always protected.

6. Retaining and Deleting Personal Data

6.1. We will keep your personal data for as long as is necessary for the purpose for which we initially collected them. Once such period has ended, we will keep your personal data for the longest of the following periods: a) any retention period set out in our retention policy which is in line with regulatory requirements relating to retention; or (b) the end of the period in which legal action or investigations might arise in respect of the services provided.

6.2. Once the retention period of your personal data lapses, we will ensure that your personal data are either irreversibly anonymised or securely destroyed.

7. Collection and Processing of End Users Data

7.1. We obtain your personal data through your browsing information archive files, as informed via the cookies policies of the websites of each of our Publishers (websites which show our advertising banners or other ad formats). We obtain data as such: URL of the website displaying our ads, referral URL, IP, country, geographical area, browser and operating system, etc.

7.2. We may collect and process your data depending on the service we provide to each partner. We may use your personal data to show ads relevant to you in the context of the partner's website you are visiting at any time and with the legitimate interest to identify any possible fraud of our clients.

7.3. We will only process your personal data when the law allows us to and when expressly authorized through an agreement with our partners, who have informed you of our collection of your personal data, with the aim of showing ads relevant to you.

8. Confidentiality and Security

8.1 We deploy various security measures such as encryption and authentication tools in line with the current state of the art to protect and maintain the security, integrity and availability of your personal data.

8.2 100% protection against unauthorized access in the case of data transfers across the internet or a website cannot be guaranteed, but we and our service providers and business partners do our utmost to protect your personal data in line with the prevailing data protection

legislation by means of physical and electronic physical precautions. Among other things, we use the following measures:

- Strict criteria for authorisation to access your personal data on a “need-to-know” basis only and exclusively for the specified purpose;
- Transfer of acquired data in secured form;
- Storage of confidential data in our secure servers;
- Firewall safeguarding of IT systems to provide protection against unauthorized access, and
- Continuous monitoring of access to IT systems to detect and prevent the misuse of personal data.

9. Changes to this Policy

9.1. We may update this privacy policy from time to time by publishing a new version on our Website.

9.2. We will notify you appropriately when we make changes to the privacy policy and we will amend its revision date so that you know when we last amended it. We do however encourage you to review this statement periodically so as to always be informed about how we are processing and protecting your personal information.
